Item 3: Disciplinary Information

In December 2013, a previous client of Mr. Horton's submitted a written complaint to Mr. Horton's prior firm, alleging she was never informed that a market value adjustment could apply if disbursing funds from her Set Rate Annuity (SRA) account. The complaint was ultimately settled by the prior firm with no contribution made by Mr. Horton.

In May 2009, Mr. Horton filed for bankruptcy, chapter 7, through the U.S. Federal Court in Athens, GA. In September 2013 the bankruptcy was discharged.

Item 4: Other Business Activities

Mr. Horton is the owner of LingerLongerEntertainment.com for which he provides professional wedding MC and DJ services. Mr. Horton received additional compensation for services offered. Clients are not required to engage Mr. Horton for these services and may seek similar services elsewhere. This is a non-investment related activity and Mr. Horton spends approximately 10 hours per month on this activity.

Item 5: Additional Compensation

Mr. Horton may receive economic benefit from any person, company, or organization, in exchange for providing clients advisory services through Abich Financial. In addition to advisory fees, IARs may qualify for certain sales incentives or other types of awards based on the value of assets under management or investment products and services sold. For example, IARs may become eligible to receive additional compensation amounts, reimbursement for approved business expenses, and attendance at various forms of entertainment or attendance at events and educational conferences hosted or subsidized by the sponsors of certain investment products or third-party asset manager programs.
